Hi Zoe,

Further to yesterdays email I can confirm that DELWP also believes item 22.5 can be resolved outside of the planning panels process.

As mentioned, the flow channel associated with the southern stormwater asset (shown in Map 1 of the UGZ schedule) is located in an area identified as being of strategic importance for Growling Grass Frog (GGF) and suitable for location of a dedicated GGF wetland. DELWP had understood that the water management location footprint in the Conservation Area Concept Plan represented the outer boundary of the asset. The flow channel is however not shown in the CACP.

To be able consider potential impacts to GGF, we request further information regarding the flow channel, including functional design plans.

Do I have an update from you on the submissions for the Craigieburn North Employment Area PSP? As discussed we really need this very urgently.

The MPA would like to be in a position where we can say that we represent 'a whole of government approach'. In order to do this, we would need to agree in principle that the remaining submissions that are not marked green are not matters that need to be dealt with at Panel and can be refined between DELWP and MPA to find wording that can be used consistently between all PSPs. MPA considers that these matters are so minor that they can be confirmed offline, and do not need to be discussed in detail at Panel for this amendment.
