Officer PSP Buffer Assessment Review Updated Directional Buffer

GHD submitted to VPA version 1 of the HyGain Officer Buffer Assessment Report titled "3136365-REP-1_Officer PSP Buffer Assessment Review" on 15 August 2018. The report outlines the recommended separation distance for the site as developed based on EPA Publication 1518 and local meteorology measured at Pakenham. The Publication 1518 separation distances are designed to ensure sufficient buffer between industry and sensitive uses such that the amenity of any sensitive uses are protected against odour or dust impacts due to non-routine or upset plant conditions.

GHD has prepared an updated directional buffer for the HyGain site at Officer to account for a change to the envelope of sources. The changes to the envelope of sources are described below:

- Material processing buildings are included in the envelope of sources, specifically process areas
 where heat is applied to materials. These areas are included in the source envelope to account for
 emissions of odours with the potential to lead to off-site nuisance in the event of upset conditions.
- All air extraction systems and dust removal systems are included in the envelope of sources. These
 sources are located at the sides of processing buildings considered above. These areas are included
 in the source envelope to account for non-routine elevated levels of particulate emissions due to
 events such as 'holes in dust socks'. HyGain has indicated¹ that these events could be expected to
 take place at a frequency of once per year.
- The following emission sources are excluded from the envelope of sources as they are identified as
 having routine emissions of either odour or dust, but with little potential for upset conditions leading
 to elevated levels of emissions:
 - Wheel generated dust
 - Dumping of grains/unloading of trucks
 - Silos

- Warehousing of products

The updated buffer is attached in Figure A below. Note that all changes to the buffer are based on modifications to the envelope of sources only. No adjustment has been made to the meteorological data or pattern of dispersion.

The directional buffer provided in this document is subject to the limitations and assumptions outlined in the GHD Assessment Report "3136365-REP-1_Officer PSP Buffer Assessment Review" dated 15/08/2018, unless stated otherwise in this document.




