**RE: Amendment C243Hume to the Hume Planning Scheme – Sunbury South and Lancefield Road Infrastructure Contributions Plan**

I refer to VPA's letter dated 4 April 2020 for the Notice of Exhibition for Amendment C243Hume to the Hume Planning Scheme – Sunbury South and Lancefield Road Infrastructure Contributions Plan (ICP).

DoT understands the amendment seeks to replace the existing interim ICP dated November 2019 with the current iteration dated April 2020.

DoT has no objections to the ICP and makes the following comments:

- DoT supports the realignment of PAO2 as proposed by Council;
- DoT understands for transport infrastructure, costings may be attributed under different components e.g. sections of retaining walls for road under rail project within the Sunbury South PSP is attributed to the structure (SS-BR-04) and road (SS-RD-04-5) as discussed with the VPA;
- Interim design associated with any State arterial roads, e.g. intersections, should minimise the need for rework for the ultimate design to the satisfaction of DoT;
- Major Roads Projects Victoria (MRPV) is the lead agency for the design and delivery of the Northern Roads Upgrade package of works. The works includes the upgrade of Sunbury Road which intersects the Sunbury South PSP. Consequently, any infrastructure and associated costings must tie in with the Sunbury Road Upgrade both in the interim and ultimate. The following design comments are made:
  - VPA Drawing 2113308A-Civ-1102 shows a through lane heading from Lancefield Road into the newly proposed development, MRPV's reference design has not accounted for this through lane (refer attached MRPV Drawing CIV-2014 Sheet No. 14). It is unlikely that MRPV's design at this location will change.

- VPA Drawing 211308A-CIV-1103 &1104 shows a wide median (approximately 10m). MRPV's reference design at this location shows a 2.2m median (refer attached MRPV Drawing CIV-2012 Sheets No.10 to No. 13) It is unlikely that MRPV's design at this location will change. Therefore, the wide median as shown on VPA's drawings would need to be built by others and match into MRPV's design on either end.
