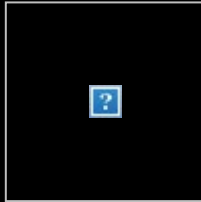

No Quarry.

To Whom it may concern,

I am writing to you today because I do not want the proposed quarry to go ahead in Beveridge North West. I would really appreciate it, if you could block this quarry for our community.

I have lived on Old Sydney Rd Wallan since June 2016. My property is about 1,200 metres away from the proposed Quarry site. I first heard there is a planned Quarry to go near my house in November 2021. On the 25th of November 2021, I received a letter from the Victorian Planning Authority.

I have not been informed about this quarry very well. I take some responsibility for this because I keep to myself a lot. However, at the moment my house is the 6th closest house to the proposed quarry site. I believe the Victorian Planning Authority should have informed me they were considering this quarry a lot earlier than in November 2021.

I talked to some friends in Beveridge and they only found out about the proposed quarry in November 2021 as well. I realized there must be a lot of other uninformed community members as well.

I think this quarry will be bad for our community. Amendments C158 does not mention when the community will get the schools and sports facilities. I am concerned that we will get the quarry and not much else. The noise and damage to our roads caused by quarry trucks will exceed the benefit of thirty jobs that the quarry might provide locals.

I did a lot of research before buying my property in 2016. Wallan was the best investment at the time. I purchased 45 acres which came with a massive bank loan. My property is my life savings and retirement. It is unfair if a big corporation can come into my area and destroy my property value without compensating

me.

My parent's house is 2.5km away from the Goulburn Valley train line. They can still hear trains going past very loudly. I think this quarry's 500m buffer is a joke. The quarry should be put 4km's away from any houses. Residents living within 4km should be financially compensated for the blast / truck noise. The Oaklands Junction quarry is 1,800 metres away from the nearest housing communities.

Our community does not want this quarry. We are getting tricked, deceived and forced to take this quarry. We would be very thankful if you could please be a voice for the Wallan / Beveridge community and please block this quarry.
