Dear Hon. Richard Wynne,

I am writing on behalf of my household to inform you that we are against the planning for the development of the Amendment C15 – Beveridge North West PSP.

We feel that having a quarry in the area chosen would be detrimental to all land owners and households within the local and wider community.

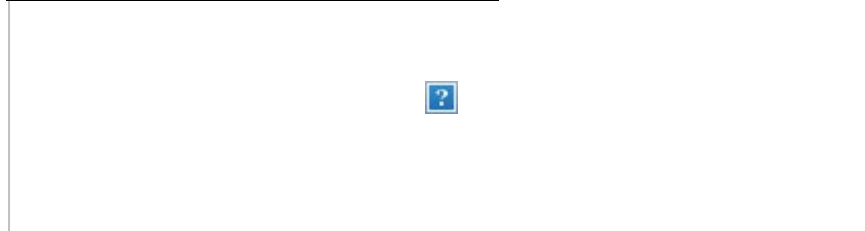
