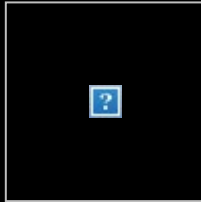

There is a lack of information about how the quarry will operate. Where is the connection to the Northern Highway which is already extremely congested and dangerous coming off the Hume. Adding more intersections to this stretch of road will only make this worse.

Emergency service and fire truck vehicles will impacted by delays.
