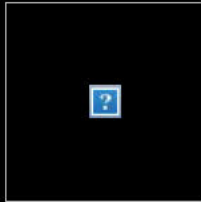

Amendment C158 – Beveridge North West PSP

I write to you to express my dismay that anyone would even consider placing a basalt quarry at 175 Northern Highway Wallan.

Wallan and Beveridge as you would be aware are a major part of the Northern Growth Corridor, and people have made one of the biggest decisions that they will make in their lives to purchase their homes in this area, based on that fact.

Fully believing that they would be living and raising their families in a semi-rural environment which provides fresh air and a more peaceful way of life, yet this proposal would irrevocably destroy any livability of this area.

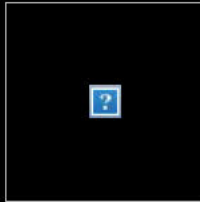
