OVERVIEW

The Victorian Planning Authority (VPA) is working to prepare a Precinct Structure Plan (PSP) and Infrastructure Contributions Plan (ICP) for the Melton East PSP. Melton East PSP is approximately 1,005ha in size and is located in Melbourne's western growth corridor. The PSP will facilitate the development of a mostly residential precinct taking into consideration key biodiversity values and localised employment opportunities. <u>PSP 2.0 guidelines</u> and processes are integrated into the development of the Melton East PSP.

PURPOSE

The purpose of the stakeholder update is to provide up-to-date information to stakeholders regarding the progress of the planning process. These updates will be provided bi-monthly throughout the project.

NEXT STEPS

- Continuing and completing Phase 1 Technical Studies. The VPA have hired technical
 experts to undertake most of the background assessments. The contractors have been
 briefed on the PSP and are at various stages of their assessment.
 - A progress list for each technical study is provided below.
- All technical experts who require access to sites have been notified to contact owners at least 1 week before arrival, or according to the arrangements provided in the land access forms
- We are expecting completion of most of the Phase 1 Technical Studies between June to September 2022.
- The Vision and Purpose Workshop has been organised for Monday 27th of June 2022.
- Invitations have been sent out via email to all landowners and other key stakeholders.
- The Vision and Purpose Workshop will be a continuation of the Pitching Sessions
 previously undertaken and will be an opportunity for all stakeholders to meet and discuss
 the vision and objectives for the precinct.
- The information discussed will be recorded and transferred into a summary document to be provided to all stakeholders in the months following the workshop.
